The product manufactured by the company mentioned above is a special paper and board grade which is used for the manufacture of toys, toy packagings, and as lining paper for books and leaflets.

It was examined by us under consideration of the

BfR-„Methodensammlung zur Untersuchung von Papier, Karton und Pappe für den Lebensmittelkontakt“, aktueller Stand, in Verbindung mit dem BfR-Leitfaden „Untersuchung der Stoffübergänge von Bedarfsgegenständen aus Papier, Karton und Pappe“ vom 26.02.2015,

(BfR-“Collection of methods for the examination of paper and board for food contact” of the, current state), in connection with the BfR guideline “Examination of the transfer of substances from consumer products made of paper and board”, as of 26.02.2015),

for the used raw materials, fabrication additives and special paper finishing agents as well as for the release of substances which might endanger health.

Furthermore, the paper grade was examined for the migration of certain elements according to the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of June 2021,
and the absence of non-approved amines and dyestuffs according to the

DIN EN 71, part 10 "Safety of Toys, Organic chemical compounds – Sample preparation and extraction", state of March 2006,
as well as the

DIN EN 71, part 11 "Safety of Toys, Organic chemical compounds – Methods of analysis", state of January 2006.

The special paper and board grade is in compliance with the rules of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, lastly modified by article 5 of the Regulation (EU) 2019/1381 of 20 June 2019, Official Journal of the European Union L 231/1 of 6 September 2019, article 3, 1. as well as of the

The demands of the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of June 2021,
regarding the migration of certain elements as well as of the

DIN EN 71, part 9 "Safety of Toys, Organic chemical compounds – Requirements", state of September 2007,

regarding the transfer of organic chemical compounds applicable for paper are also kept.

Thus the special paper and board grade **Chromo paper, up to and including 240 gsm** according to the sample material submitted may be used safely for food packaging. It may stand in direct contact with dry, non-fatty and such kind of foodstuffs which are peeled, shelled or washed before consumption.

This certificate of compliance has a validity of two years and consists of 4 pages.
